Congratulations on your acceptance for membership in the 2022 Diamond Commercial Contractor[®] program for the years 2022 to 2024. Diamond Commercial Contractors (DCC's) have demonstrated their deep product knowledge, expertise and experience through a series of eligibility requirements and qualifications. If your firm is a past DCC who has been reaccepted into the program, you have no current training requirements. If your firm is new to the DCC program then you will need to complete the classes shown below:

Diamond Designer Seminar (DDS) – this class teaches students how to properly design and apply CITY MULTI[®] VRF systems in HVAC applications. The attendee will learn to differentiate between the different types of CITY MULTI[®] systems and properly apply them, as well as compare energy usage and first cost between the different types of CITY MULTI[®] systems. The class culminates with the student designing an HVAC system using the Diamond System Builder (DSB) software.

<u>**City Multi Essentials</u>** - Installation (Day 1) is now an e-learning module completed prior to attending in person classes. The focus is on best practices, limitations, wiring, addressing, refrigerant piping and equipment installation. Control and System Set-up (Day 2) focuses on concepts of integration and centralized control, steps for system start-up and hands-on experience building systems using the DSB design software. Service (Day 3) focuses on system operation, electrical and refrigerant circuits, techniques to diagnose and troubleshoot CITY MULTI systems and includes practical hands-on exercises with system faults and repair techniques.</u>

Ongoing training required to maintain your status as a DCC for the full 3 year term will be determined as METUS launches new products such as Hybrid VRF and / or the next generation of CITY MULTI[®] equipment.
